GENERAL INFORMATION

SUPRA-BOR is a clear solution of plant food that when used according to recommendations will help control boron deficiencies. It is specially formulated to enhance uptake and leaf absorption as well as solubility in both water and NPK fertilizer materials.

SUPRA-BOR can be tank mixed with water and/or most pesticides and incorporated in NPK fertilizer materials. It can be foliar sprayed, injected through irrigation systems or applied broadcast.

Foliar: Supra-Bor will disperse in water with minimum agitation, follow the mix sequence:

- 1. Wate
- 2. Boron
- 3. Pesticide Min. GPA: 20 ground, 5 air

Fluid Fertilizer Mfg.:

Supra-Bor does not require premixing before addition to fertilizer. When mixing in a batch tank, add to water or nitrogen solution before adding phosphate material. Mix thoroughly.
