DIRECTIONS FOR USE

SUPRA-T&O 15-0-12 will disperse in water with minimal agitation. It can be tank mixed with most pesticides and fertilizers. Always make a small-scale test to assure compatibility. Follow the mixing sequence:

1. Water; 2. SUPRA-T&O 15-0-12; 3. Other fertilizer; 4. Pesticide.

Spray volumes should not exceed 25 gal per acre due to the possibility of excessive run-off.

RECOMMENDED RATES

Turfgrass: Starting in the early spring, apply 7-16 fluid oz. per 1,000 sq. ft. every 4 weeks or as needed.

Greens, Tees, Fairways: Apply 7-16 fl. oz. per 1,000sq. ft. in no less than 2 gal. of diluted mix per 1000sg. ft. Can be applied every 7-21 days or along witha summer disease program.

Trees, Shrubs: For deep root feeding, mix 1-5 gal. per 100 gal of water. Inject 1-5 gal per inch of trunk diameter at chest height.
