**SUPRA-T&O Micros for Turf** is a liquid formulation of essential plant nutrients and micronutrients that aids in the prevention and correction of micronutrient deficiencies, especially in higher pH soils where trace elements often become unavailable to the plant.

## DIRECTIONS FOR USE

**SUPRA-T&O Micros for Turf** will disperse in water with minimal agitation. It can be tank mixed with most pesticides and fertilizers except high phosphate materials. Always make a small-scale test to assure compatibility. Follow the mixing sequence: 1. Water; 2. **SUPRA-T&O Micros for Turf**; 3. Other fertilizer; 4. Pesticide. Use of a non-ionic surfactant is recommended for optimal leaf absorption.

## RECOMMENDED RATES

**Turf (Fairways, Greens and Tees):** Apply 2-6 fluid oz. per 1,000 sq. ft. or 3-6 quarts per acre in enough water to cover.

**Trees and Ornamentals:** Apply 4-6 quarts per 100 gallons of water as a foliar spray or drench as necessary. Use sufficient water for good coverage.

This product may be corrosive to aluminum, mild steel and brass. Store in HDPE, fiberglass or stainless steel containers. Use only stainless steel, P.V.C. or polypropylene fittings. **Storage:** Store in a cool place in original container in a locked storage area inaccessible to children, pets, domestic animals or wildlife. **Container Disposal:** Do not reuse empty containers.
